**Choose and Option Below:**

Option A: The student/family will be financially responsible for all tuition and the cost of all textbooks, materials, and fees associated with the CCP course(s). The student must inform the high school whether they want to receive college credit only or both high school and college credit.

Option B: The state of Ohio is financially responsible for the eligible CCP course(s) in which the student enrolls. This option requires the student receive high school and college credit for each enrolled class.

Combination of Option A & B: The student/family choose to be responsible for all tuition, textbooks, and fees for one or more courses. This option requires the student to inform the high school of which course(s) will fall under Option A and which will be under Option B.

I understand that if I **fail** a course or withdraw late, I may be required to pay for the cost of the class.

I also understand that:

- it is my responsibility to notify my school if I do not gain admission to my selected institution of higher education or choose not to participate for some other reason.
- I may be **excluded from any academic related honors until the end of the school year.**
- I will check with TVHS library FIRST for any textbooks\* I need that have already been purchased.
  - \*ZSC textbooks are free for CCP Campus students
- It is my responsibility to check Tri-Valley’s website or contact the school for any information including, but not limited to: Graduation exercises, prom, meetings, fees, extracurricular functions etc.
- It is my responsibility to review course selections with the High School Counselor to ensure graduation requirements.
- I will turn all textbooks in to the Tri-Valley High School Library within three (3) days of the end of each semester.
- **I understand that I will be required to reimburse fees for failed courses or withdrawn after the deadline.**
- I understand that full repayment will need to be received prior to graduation or release of any school records.

In addition, I certify that I have viewed, IN FULL, the online College Credit Plus presentation. I understand the rules and regulations for both my school and the college, and I understand my responsibilities, the benefits and possible risks of participating in the College Credit Plus program.
